OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THESE SWEEPSTAKES. A PURCHASE DOES NOT IMPROVE AN INDIVIDUAL'S CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. Eligibility. The Las Vegas Motor Speedway Virtual Fan Garage ("**Sweepstakes**") is open to legal residents of the 48 contiguous United States (including the District of Columbia). Entrants must be 21 years old or the age of majority in their state of residence at the time of entry. This Sweepstakes is subject to federal, state, and local laws and regulations and void where prohibited by law. Employees, officers and directors, of Nevada Speedway, LLC d/b/a Las Vegas Motor Speedway and its respective parent companies, affiliates, subsidiaries, agents, suppliers, partners, advertising and promotion agencies and all others engaged in the development, production or distribution of promotional materials or prizes for this Sweepstakes (**collectively, the "Sweepstakes Entities"**), and their immediate families (parents, siblings, children and spouses of each, regardless of where they live) and members of the households (whether related or not) of such employees, officers and directors, are ineligible to participate in this Sweepstakes.

2. Sponsor. The sponsor is Nevada Speedway, LLC d/b/a Las Vegas Motor Speedway, located at 7000 Las Vegas Blvd., North, Las Vegas, Nevada 89115. Sponsor will conduct this Sweepstakes substantially as described in these Official Rules

3. Agreement to Rules. By entering this Sweepstakes, the participant ("**Entrant**" "**You**" or "**Your**") agrees to abide by the Sponsor's Official Rules and decisions, which are full and unconditionally binding in all respects. The Sponsor reserves the right to refuse, withdraw, or disqualify any entry at any time at the Sponsor's sole discretion. By entering this Sweepstakes You represent and warrant that You are eligible to participate based on the eligibility requirements explained in the Official Rules. You also agree to accept the decisions of the Sponsor as final and binding as it relates to the content of this Sweepstakes.

Each Beacon represents an Individual Sweepstakes. As an Entrant, Your Individual Sweepstakes entry must fully meet all Sweepstakes requirements, as specified in the Official Rules, in order to be eligible to win a prize for that Individual Sweepstakes. Incomplete entries or those that do not adhere to the Official Rules or specifications will be disqualified at the Sponsor's sole discretion. Limit one (1) entry per Individual Sweepstakes during the Sweepstakes Period. Sponsor is not responsible for lost, late, incomplete, misaddressed, or otherwise misdirected Entries that are processed late or incorrectly or are lost due to computer or electronic malfunction or other error. Sponsor is not responsible for nor shall have no liability for a Winner's failure to receive notices due to email security settings that may cause notifications to be marked as spam or junk email. Nor shall be Sponsor be liable for a Winner's provision of incorrect or otherwise non-functioning contact information. If the Winner 1) fails to claim the Prize within [10 days] from the time the award notification was sent, 2) is found ineligible, or 3) if applicable, does not complete and return an executed declaration and release within the specified timeframe, the Prize may be forfeited and an alternate Winner may be selected.
