

# THE FALL CLASSIC 2019 SUPER STOCK

## **RULES AND GENERAL TECH WILL BE BASED ON LVMS SUPER STOCK RULES WITH THE FOLLOWING EXCEPTIONS.**

- Minimum weight for Camaros and Firebirds is 3200 lbs with 55.0% left side weight with driver. Minimum weight for any other model of car is 3100 lbs with 55.0% left side weight with driver. No vehicle can exceed the 55.0% left side weight rule or 50% rear weight percentage at anytime. Stock front stub/Leaf Spring fabricated chassis permitted with 3200 lbs and 54% left side weight rule.
- <u>All suspension pick-up points must remain OEM. Please refer to 2019 Bullring Super Stock</u> rules. If altered from OEM, please call (702) 632-8223 for weight penalties.
- All bodies must be steel and remain within factory lines. Fiberglass, "AERO BODY" must add 25 lbs, and have 54.0% left side weight maximum, rear window not permitted. Plastic or fiberglass nose permitted.
- No part of the Chassis, Body or Weights shall be lower than 4" with driver in the car at any time when measured in tech inspection. Cross members, Oil pans and exhaust systems do not have a height rule, however if any part of the car excessively drags the track when the car is in competition they will receive the black flag.
- One spoiler mounted at the rear of the deck lid meeting the following requirements: Must not be more than 6" high, not to extend any farther than the rear deck width, and not to exceed 60" measured across the back edge. Wings prohibited.
- Built Vortec headed motor permitted with dual plane intake manifold must add 50 lbs.
- GM 602 Factory sealed crate motor with Holley 4412 2 barrel carburetor remove 75 lbs.
- GM 602 Factory sealed crate motor with Holley 80541-1 4 barrel carburetor permitted.
- All camshafts MUST be flat tappet and have a maximum of .450 lift measured at the valve. Any flat tappet camshaft exceeding .500 lift must ADD 25 lbs. Roller tipped rockers permitted.
- Maximum compression of 10.0:1. Compression over 10.0:1 will add 25lbs
- Gauge legal Holly 4412 500 CFM carburetor on built motors and Holley 80541-2 650 CFM carburetor on GM 602 crate motors, MUST BE BOX STOCK, choke butterfly may be removed. Choke horn may be removed with square cut mill only. Edges may not be radiused, filed, or otherwise deburred.
- Any aluminum intake manifold allowed. Intake manifold must be box stock and untouched. Intake manifold may not be ported or gasket matched.
- Exhaust headers are permitted. Your home track exhaust rules apply.
- No coil over shocks permitted. Shocks may not be gas charged. Front shocks mounted in stock location remove 25lbs. Shock mounting is subject to tech approval. <u>No bump stops.</u>
- Springs must remain in factory location, weight jacks are permitted. <u>All Suspension must drop</u> <u>2" from ride height when jacked up.</u>

- No "Slip type" differentials permitted. Only Steel spool, steel mini spool, or welded spider gears permitted. No lightening of ring and pinion or spool permitted. No traction control devices permitted. No "Lockers".
- LVMS track fuel only permitted to be used.
- Hoosier Tire West will be on property to supply tires. If your home track uses Hoosier 970 tires you will be permitted to run those at this event with tech approval.
- All cars must run steel wheels. 15"x8" is the maximum width of any wheel permitted.
- The maximum track width permitted is 78" outside of tire to outside of tire.
- Helmets are required and must be Snell SA2000 or newer. Helmets must be worn at all times while on the track surface. Helmet must accompany vehicle at time of inspection. Fire suits, fire resistant gloves, fire resistant shoes and neck braces required. Fire resistant underwear recommended.
- FIRE EXTINGUISHER OR FIRE SUPPRESSION SYSTEM MANDATORY.
- Seat belts and window net must be in good condition and must be within the manufactured suggested replace time.
- Top 3 finishers motors will be subject to being whistled and being pumped or tear down at the discretion of LVMS officials.
- LVMS reserves the right to amend these rules at anytime.
- LVMS reserves the right to add weight at anytime to any competitor in the fairness of competition.
